

Training program on “Worker's participation in Safety Management”

Dear Sir,

The first National Conference on Safety in Mines held on 5th - 6th August 1958 emphasized on role of workmen suggesting that

-

- "Workmen and their representatives should co-operate with the management in ensuring effective compliance with safety measures and precautions".
- "Workmen should have the right to get the mines inspected by their chosen representatives".

The Fifth Safety Conference recommended amendment in the Mines Act to give statutory backing to the institutions of Pit Safety Committee and Workmen's Inspectors.

Subsequently Chapter IV-B titled "Workmen's Inspectors and Safety Committee" was inserted in the Mines Rules 1955 vide Notification no. GSR 316, dated 14th April 1986.
